In this connection, it is intimated that as per your application & process flow chart, affidavit, Project Report submitted by you, you will be engaged in process of pouching process (without plastic manufacturing, dry process without trade effluent and without any air emission). As per process, there will be no discharge of trade effluent and air emission from the process except DG set. The unit is exempted from consent management of HSPCB as per latest modified direction for categorization of industries of CPCB dated 07-03-2016. Hence you need not to obtain NOC/Consent on the following grounds:-

10.	That the unit will comply the rules, regulation, directions issued by HSPCB from time to time.	
11.	Unit will seek prior NOC/CTO from the board incase unit change its process to a polluting process or discharge increase more 10 KLD	
12.	Unit will obtain all clearances from concerned agencies where ever required	
13.	Unit will comply with all the environmental laws/rules, notifications issued by GOI/State Govt./HSPCB from time to time.	

Kindly note that your NOC/Exemption stands revoked automatically in case of any change in Govt./Board Policy, in case of Violation of any Act/Rules and if unit will start any polluting process without prior permission of the Board. As per direction of Hon'ble High Court Punjab & Haryana, industrial activities are not allowed in residential/non-confirming area without approval/permission from all concerned departments. This letter does not exempt the unit from obtaining necessary permission from the other department like Town and Country Planning/HUDA/ Panchayat etc.
